Item-writing workshops are hosted two to three times each year, with each workshop running from two to four days.

### **Eligibility Requirements**

# To be eligible to take part, you must be a CFP professional and have completed the CFP examination within the past 10 years, with:

- A willingness to work collaboratively and give and receive constructive feedback;
- A commitment to enhancing your own skills; and
- Extensive financial planning expertise, preferably with specialty knowledge in one or more of the following areas: financial management, asset management, risk management, tax planning, retirement planning and estate planning.

### **Application Process**

If you're interested in this opportunity, please submit include a covering letter and current resume or CV that includes the following information:

- Writing experience;
- Current job responsibilities;
- Accomplishments in the field of financial planning and specialist expertise;
- Current or previous committee work; and,
- Any potential conflicts of interest.

### **Selection Process**

As an applicant, you may be asked to participate in an interview as part of the selection process. You must also be free of conflicts of interest (for example, you are ineligible if you are an examination preparatory course provider or involved in any other situation where the information discussed or the materials used during the examination development process would be directly related to your work). You'll be expected to sign and adhere to a Confidentiality Agreement and an Acceptable Use Policy.
