Eligibility Requirements

To be eligible to take part, you must be a CFP professional with a minimum 10 years client facing financial planning work experience and:

- A willingness to work collaboratively;
- A commitment to enhancing your own skills; and
- Extensive financial planning expertise, preferably with specialty knowledge in one or more of the following areas: financial management, asset management, risk management, tax planning, retirement planning and estate planning.
